Our audit has been conducted in accordance with Australian Auditing Standards. These procedures have been undertaken to form an opinion whether, in all material respects:

- (a) the Statement presents fairly, in accordance with applicable Accounting Standards in Australia and the books and records of the Aces Sporting Club Inc.; and
- (b) the Statement is consistent with our understanding of sections 3.6.9(2)(a) and (b) of the Gambling Regulation Act 2003.
