## **Report on the Community Benefit Statement**

We have audited the Community Benefit Statement, of Polish Community Association in Geelong Inc., for the year ended 30 June 2024.

An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the directors, as well as evaluating the overall presentation of the Community Benefit Statement.
