### **Independent auditor's report to the members of Amstel Golf Club Inc.**

We have audited the accompanying Community Benefit Statement of the gaming facility of the Amstel Golf Club Inc. for the year ended 30 June 2014. We have concluded an independent audit of the Community Benefit Statement in order to express an opinion on it to the members of Amstel Golf Club Inc. for the purposes of fulfilling the requirements of Section 3.6.9 (2)(C) of the Gambling Regulation Act 2003.

The Community Benefit Statement has been prepared for the distribution to the Victorian Commission for Gambling Regulation pursuant to the Gambling Regulation Act 2003. We disclaim any assumption of responsibility for any reliance on this report or the Community Benefit Statement to which it relates, to any party other than the members of Amstel Golf Club Inc. or for any purpose other than that for which it was prepared.

#### *Directors' Responsibility for the Financial Report*

The directors are responsible for the preparation and fair presentation of the Community Benefit Statement in accordance with Australian Accounting Standards (including the Australian Accounting Interpretations) and with section 3.6.9 of the Gambling Regulation Act 2003. This responsibility includes establishing and maintaining internal controls relevant to the preparation and fair presentation of the Community Benefit Statement that is free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

#### *Auditor's Responsibility*

Our responsibility is to express an opinion on the Community Benefit Statement based on our audit. We conducted our audit in accordance with Australian Auditing Standards. These Auditing Standards require that we comply with relevant ethical requirements relating to audit engagements and plan and perform the audit to obtain reasonable assurance whether the Community Benefit Statement is free from material misstatement.
