

## **INDEPENDENT AUDITOR'S REPORT TO THE COMMITTEE OF THE ST ALBANS SPORTS CLUB INCORPORATED**

### *Opinion*

We have audited the compliance of the accompanying Community Benefit Statement of St Albans Sports Club Incorporated for the year ended 30 June 2019.

In our opinion, the Community Benefit Statement of St Albans Sports Club Incorporated has complied, in all material respects with sections 3.6.9(2) (a) and (b) of the *Gambling Regulation Act 2003* for the year ended 30 June 2019.

### *Basis for Opinion*
