Audit Opinion

As the Statement has been prepared for the purpose of fulfilling the Committee's reporting responsibilities under the Act, the Statement may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

The Committee is responsible for the preparation and fair presentation of the Statement and has determined that the basis of preparation is appropriate to meet the requirements of the Commission in reporting the community benefit contributions as required by Section 3.6.9 of the Act.
