### **Audit Opinion**

We have audited the attached Community Benefit Statement (the Statement) of Frankston RSL Sub Branch Inc. (the Sub-Branch) for the financial year ended 30 June 2018.

The Statement is prepared in accordance with the relevant sections of the Act, together with the instructions issued by the Victorian Commission for Gambling Regulation (the Commission), which determine the basis of preparation of the Statement. As the Statement has been prepared for the purpose of fulfilling the Committee's reporting responsibilities under the Act, the Statement may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

#### Committee's Responsibility for the Statement

The Committee is responsible for the preparation and fair presentation of the Statement and has determined that the basis of preparation is appropriate to meet the requirements of the Commission in reporting the community benefit contributions as required by Section 3.6.9 of the Act. The responsibility also includes such internal control as the Committee determines necessary to enable the preparation of a Statement that is free from material misstatement, whether due to fraud or error.
