Report on the audit of the Community Benefit Statement

Opinion

We have audited the Community Benefit Statement of Sunbury Sports & Community Club Inc for the year ended 30 June 2023.

In our opinion, the Community Benefit Statement in relation to the Sunbury Sports & Community Club Inc presents fairly in accordance with applicable Accounting Standards in Australia, and is consistent with our understanding of sections 3.6.9(2) (a) and (b) and 3.6.9(3) of the Gambling Regulation Act 2003 (the Act).

Basis for opinion
