INDEPENDENT AUDIT REPORT COMMUNITY BENEFIT STATEMENT FOR YEAR ENDED 30 JUNE 2008

Scope

We have audited the Community Benefit Statement in relation to compliance with sections 3.6.9(2)(a) and (b) of the Gambling Regulations Act 2003 ("the Act"). The Manager of the North Suburban Sports Club Inc. is responsible for the Community Benefit Statement.

The statement has been prepared to ensure that the Community Benefit Contribution is greater than the minimum requirement of 8.33% of the venue operator's gaming machine revenue for the year.
