**Report on the Audit of the Community Benefits Statement**

**Opinion**

We have audited the attached Community Benefits Statement (the Statement) of Dandenong Cranbourne RSL Sub Branch Inc. For the financial year ended 30 June 2017.

In our opinion, the Community Benefits Statement of Dandenong RSL presents fairly, in all material respects, in accordance with the requirements of sections 3.6.9(2)(a) and (b) and 3.6.9(3) of the Gambling Regulation Act 2003, the community benefit contributions made by the Sub Branch for the financial year ended 30 June 2017.

**Basis for Opinion**

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Statement* section of our report. We are independent of the Sub Branch in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110: *Code of Ethics for Professional Accountants* (the Code) that are relevant to our audit of the Statement in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

**Emphasis of Matter - Basis of Accounting**

The Statement is prepared in accordance with the relevant sections of the Act, together with the instructions issued by the Victorian Commission for Gambling Regulation (the Commission), which determine the basis of the preparation of the Statement. As the Statement has been prepared for purpose of fulfilling the Committee's reporting responsibilities under the Act, the Statement may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

**Responsibilities of the Committee of Management for the Statement**

The Committee of Management of Dandenong RSL is responsible for the preparation and fair presentation of the Statement and has determined that the basis of preparation is appropriate to meet the requirements of the Commission in reporting the community benefit contributions as required by Section 3.6.9 of the Act. The responsibility also includes such internal control as the Committee determines is necessary to enable the preparation of a Statement that is free from material misstatement, whether due to fraud or error.

**Auditor's Responsibilities for the Audit of the Statement**

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.
