Community Benefit Statement

Scope

I have audited the attached Community Benefit Statement of the Doxa Social Club for the year ended 30 June 2006. The Club's management is responsible for the financial report and has determined that the accounting policies used are consistent with the applicable Accounting Standards in Australia. I have conducted an independent audit of Community Benefit Statement in order to express an opinion on it to the members of the Doxa Social Club. My audit has been conducted in accordance with the Australian Auditing Standards applicable, in particular to Australian Auditing Standard AUS802 "The Audit Report of Financial Information Other than a General Purpose Financial Report" and with my understanding of Sections 3.6.9(2)(a) and (b) of the Gambling Regulation Act 2003. My procedures included examination, on a test basis, of evidence supporting the amount and other disclosures in the Community Benefit Statement. These procedures have been undertaken to form an opinion as to whether, in all material respects, the Statement is presented fairly in accordance with the applicable Australian Accounting Standards. (These policies do not require the application of all Accounting Standards).

The audit opinion expressed in this report has been formed on the above basis.

In my opinion:

The Community Benefits Statement

(a) Presents fairly in accordance with applicable Australian Accounting Standards and the Doxa Social Club's management's compliance with Sections 3.6.9(a) and (b) of the Gambling Regulation Act 2003 in relation to Clock's Pokies for the year ended 30 June 2006.

(b) The Community Benefit contribution of the Doxa Social Club in regard to the Clock's Pokies is greater than 8% of gaming machine revenue for the year ended 30 June 2006.
