Opinion

We have Audited the accompanying Community Benefit Statement (the Statement) of City Memorial Bowls Club Warrnambool Inc. for the financial year ended 30 June 2023.

In our opinion, the Community Benefit Statement City Memorial Bowls Club Warrnambool Inc. presents fairly in all material respects, in accordance with the requirements of sections 3.6.9(2)(a) and (b) of the *Gambling Regulations Act 2003* (the Act), the community benefit contributions made by the entity for the financial year ended 30 June 2023.

Basis for Opinion

We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the Audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter - Basis of Accounting and Restriction on Distribution and Use

The Statement is prepared in accordance with the relevant sections of the Act, together with the instructions issued by the Victorian Commission for Gambling Regulations (the Commission), which determine the basis of preparation for this Statement. As the Statement, has been prepared for the purpose of fulfilling the Boards reporting obligations under the Act, the Statement may not be suitable for another purpose. Our opinion is not modified in this respect.

Responsibility of the Responsible Entities for the Statement

The Board is responsible for the preparation and fair presentation of the Statement and has determined that the basis is appropriate to meet the requirements of the Commission in reporting the community benefit contributions as required by Section 3.6.9 of the Act. The responsibility also includes such internal controls as the Board determines necessary to enable the preparation of a Statement that is free from material misstatement, whether due to fraud or error.

Auditor’s Responsibilities for the Audit of the Statement

Reasonable assurance is a high level of assurance, but is not a guarantee that an Audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of the Statement.

As part of an Audit in accordance with Australian Auditing Standards, we exercise professional judgement and maintain professional scepticism throughout the Audit. We also:

- Identify and assess the risks of material misstatement of the financial report, whether due to fraud or error, design and perform Audit procedures responsive to those risks, and obtain Audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
