We have audited the compliance of the accompanying Community Benefit Statement of Mildura Working Man's Club Inc for the year ended 30 June 2025.

In our opinion, the Community Benefits Statement of Mildura Workings Man's Club Inc has complied, in all material respects with sections 3.6.9(2) (a) and (b) of the *Gambling Regulation Act 2003* for the year ended 30 June 2025.

Director's Responsibility for the Statement

The directors of the company are responsible for ensuring compliance with sections 3.6.9(2) (a) and (b) of the *Gambling Regulation Act 2003*. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates, if any, made by management, as well as evaluating the overall presentation of the Statement.
