Report on the Financial Report

We have audited the Community Benefit Statement, of The Abruzzo Club, for the year ended 30 June 2008.

Directors' Responsibility for the Financial Report

The directors of the Abruzzo Club are responsible for the preparation and fair presentation of the Community Benefit Statement and have determined that the accounting policies used are applicable and are appropriate to meet the requirements of the *Gambling Regulations Act 2003* and are appropriate to meet the needs of the members. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the Community Benefit Statement in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the directors, as well as evaluating the overall presentation of the Community Benefit Statement.

The Community Benefit Statement has been prepared for distribution to members for the purpose of fulfilling the directors' obligations under the *Gambling Regulations Act 2003*. We disclaim any assumption of responsibility for any reliance on this report or on the financial report to which it relates to any person other than the members, or for any purpose other that that for which it was prepared.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Independence

In conducting our audit, we have complied with the independence requirements of the *Corporations Act 2001*. We confirm that the independence declaration required by the *Corporations Act 2001*, provided to the directors of the Abruzzo Club on 28 May 2008, would be in the same terms if provided to the directors as at the date of this auditor's report.
